

ORDINANCE NUMBER 2013- 20

AN ORDINANCE AMENDING THE OPERATING AND CAPITAL BUDGETS FOR THE GOVERNMENT OF GREENWOOD COUNTY TO CONFORM TO RECEIPTS AND EXPENDITURES OF THE FIRST QUARTER OF THE 2013-2014 FISCAL YEAR, AND TO AMEND RATES AND FEES ESTABLISHED IN THE SAID BUDGET.

WHEREAS, Section 26 of Ordinance Number 2013-11 of the Greenwood County Council providing for the operating and capital budgets for the government of Greenwood County recommends that the said Ordinance be amended at the end of each fiscal quarter as a matter of course to conform to the receipts actually received and the expenditures actually made, and;

WHEREAS, the aforesaid Ordinance also incorporated a Fee Schedule by which the Greenwood County Council assessed certain fees upon users of the Greenwood County Landfill for sanitation and solid waste collection and disposal, and;

WHEREAS, the Greenwood County Council is empowered by the Code of Laws of South Carolina to amend the aforesaid Fee Schedule;

NOW, THEREFORE, BE IT ORDAINED BY THE GREENWOOD COUNTY COUNCIL, DULY ASSEMBLED, AS FOLLOWS:

Ordinance Number 2013-11 of the Greenwood County Council is hereby amended as set forth in the attached Amended Budget Book and Amended Fee Schedule, both of which are hereby incorporated by reference as if restated in full and adopted as part of this Ordinance.






