A RESOLUTION TO AMEND THE FISCAL YEAR 2016 BUDGET, ORDINANCE NO. 2015-07, AS IT RELATES TO THE FIRE FEE RATE SCHEDULE, AND OTHER MATTERS RELATED THERETO


NOW, THEREFORE, it is hereby Resolved by the Greenwood County Council in meeting duly assembled, that:


