- 2015-01 An Ordinance Creating a Special Tax Assessment for eligible rehabilitated historic properties
- 2015-02 An Ordinance to enter into a Pilot Agreement between Greenwood County and Project Pine
- 2015-03 An ordinance amending the Operating and Capital Budgets for the Government of Greenwood County for the fiscal year having begun July 1, 2014
- 2015-04 An ordinance amending the text of Greenwood County Zoning Ordinance 13-86 to change the formatting of Sections 6.3.4 through 6.3.44 of the commercial and industrial zoning categories
- 2015-05 An Ordinance creating a Special Tax District to be comprised of real property within the Reynolds Colony Subdivision, and other matters related thereto
- 2015-06 DENIED: An ordinance to amend the Greenwood County Zoning Ordinance, being ordinance 133-86 as and if amended, so that one parcel totaling .95 acres of land located at 101 Lost Lure in Greenwood County currently zoned WD (Waterfront Development) and the request is to rezone to RDD (Rural Development District)
- 2015-07 Providing for the adoption for the Fiscal Year beginning July 1, 2015, of operating and capital budgets for the operation of the Government of Greenwood County, the identification of the sources of anticipated revenue including taxes necessary to meet the financial requirements of budgets adopted, the levy and collection of taxes necessary to meet all county purposes, including payment of the principal and interest on outstanding indebtedness of the Greenwood Metropolitan District payable during the aforesaid fiscal year, the expenditure of the aforesaid taxes and other revenues coming to Greenwood County during the aforesaid fiscal year, the establishment of rates and fee, and other matters relating to Greenwood County

- 2015-08 An Ordinance providing for the levy of taxes for education purposes in Greenwood County, an appropriation for the said purposes for the fiscal year beginning July 1, 2015, and other matters relating thereto (First Reading)
- 2015-09 An ordinance to amend Ordinance 2013-12, pertaining to unsafe structures, including swimming pools as a structure and the maintenance of swimming pools
- 2015-10 An ordinance to amend the Greenwood County Zoning, being Ordinance 13-82, by amending the text of Sections 6-3-43 (Light Industrial), 6-3-44 I-2 (Heavy Industrial, 6-3-47 RDD (Rural Development District), and 6-3-108 Accessory Structures adding solar farms as conditional uses and listing the conditions under which solar panels may be utilized as an accessory use in all residential zoning districts.
- 2015-11 An ordinance creating a special tax district to be comprised of real property within the GraceCourt Townhouses, and other matters related thereto
- 2015-12 An ordinance amending Ordinance No. 15-03 regulating activities within the Project Boundary of Lake Greenwood
- 2015-13 An ordinance amending Greenwood County Zoning Ordinance, being Ordinance 13-86, as and if amended, so that the zoning designation of one parcel of land totaling 2.98 acres, located at 3308 Hwy 25 S can change from AG-1 (Agricultural District) to C-2 (General Commercial)
- 2015-14 An Ordinance to amend Greenwood County Zoning Ordinance, being Ordinance 13-86, as and if amended, so that the zoning designation of one parcel of land totaling 2.33 acres located at 633 Davis St, and an adjacent parcel of land totaling .61 acres of land located at 635 Davis St can change from R-4 (Two Family Residential) to AG-1 (Agricultural District)
